The Opportunity

We are seeking to hire a contract Exploration assistant who will help support exploration activities for Mines d'Or Duparquet at its exploration project. This role will be based in a dynamic team setting, reporting to, and working closely with the Geology team, you will be integral in the daily support of site activities focussed around the summer and fall work programs which will offer development and training opportunities related to exploration programs.

What you will do

As Exploration assistant, your primary duties and responsibilities will be as follows:

- Supporting surface exploration activities, such as prospecting, sampling, and other field assistant duties.
- Assisting with measuring, photography, and geotechnical logging of drill core
- Use of mobile applications for field data collection
- Safe field practices in remote areas and working around UTV's.
- Assist in taking environmental readings and running of monitoring tools.
- Moving and assisting geologic team in moving/handling core boxes
- Perform other related work as required; and such other duties and services that would be reasonably expected to be performed by a person employed by a public mineral exploration and development company in a similar position to that of the employee.

Preferred Qualifications and Education

- Ability to work independently as well as collaboratively in a multi-disciplinary, cross-cultural team.
- Proficiency in oral and written French or English communication and attention to detail.
- Health and Safety focused mindset to work safely and contribute to safe practices of the MDD's team.
- Willingness to travel and work within rural and remote site settings as this position's rotation will be determined by core seasonal activities.
- Comfortable working in a dynamic work environment with a willingness to work outdoors and able to operate vehicles, at our operations, in various weather conditions and terrain
- Must be legally entitled to work in Canada.

First Mining has commenced a Feasibility Study at Springpole where permitting activities are on-going with a draft Environmental Impact Statement ("EIS") for the project published in June 2022. First Mining also acquired a 100% interest in the Duparquet Gold Project in September 2022 and are developing plans to advance the project along with its nearby Duquesne and Pitt Projects in Quebec. The Company is the largest shareholder of Treasury Metals who are advancing the Goliath Gold Complex in Ontario. First Mining also has active partnerships with operators advancing other Canadian projects including the Pickle Crow Gold Project (Firefly Minerals) and Hope Brook Gold Project (Big Ridge Gold). In addition, First Mining owns the Cameron Gold Project in Ontario.

First Mining was created in 2015 by Mr. Keith Neumeyer, founding President and CEO of First Majestic Silver Corp.

Duparquet Project Background.

The Duparquet project is an advanced stage gold program located in the Abitibi, approximately 50 km north of Rouyn-Noranda and immediately north of the town of Duparquet.

First Mining acquired a 100% interest in the Duparquet Gold Project in September 2022 and are developing plans to advance the project along with its nearby Duquesne and Pitt Projects in Quebec through its subsidiary Mines d'Or Duparquet. The Duparquet Project mineral resource includes an open pit, underground and tailings portion. An updated NI43-101 mineral resource estimate completed in September 2022 identified 3.4 Moz in the Measured & Indicated category, with 1.6 Moz in Inferred. This mineral resource estimate includes more than 270,000 m of historical drilling completed between 2008 and 2013. The deposit is open along strike and at depth with the majority of the historical drilling less than 500 m from surface.
